SCRANTON, PENNSYLVANIA 18503

A Regular Meeting of the Board of Directors of the School District of the City of Scranton was held on Monday, April 2, 2012 in the cafeteria of the Career Technology Center, 3201 Rockwell Avenue, Scranton PA 18508 at 7:30 PM prevailing time.

President Lesh called the meeting to order at 7:58 PM with a Pledge of Allegiance to the Flag.

ROLL CALL: By the Secretary.

PRESENT: Directors Barrett, Fox, McGuigan, O'Shea, Ruane, Sheridan, Shrive and President Lesh.

Director Shrive made a motion to accept the minutes of the meeting held on February 6, 2012. The motion was seconded by Director Sheridan and passed unanimously on a roll call vote.

COMMUNICATIONS TO THE BOARD:

The Scranton School Board of Directors held an executive session on Monday March 26, 2012 at 7:00PM to discuss labor relations and personnel.

The Scranton School Board of Directors held an executive session this evening, Monday, April 2, 2012 at 7:00PM to discuss personnel.

President Lesh now waived the rules of the board and called for Visiting Delegations for the people who applied for the vacancy seat on the school board announced there would be a three minute time limit as there are plenty of speakers.

The following individuals addressed the board and spoke of their qualifications and backgrounds, and why they should be considered to fill the school board vacancy.

Dan LaMagna James E. Freethy Tom Borthwick James Timlin Joe Matyjevich Sarene O'Malley Armand Martinelli

<u>Ozzie Quinn</u> Taxpayer's Association spoke of the recent Lerta (Local Economic Revitalization Tax Assistance Act) program that was approved by the board and shared information he is aware of regarding variances.

Mr. Quinn also spoke of two bills introduced in Harrisburg; the House Bill 1776 and Senate Bill 1400 that pertain to the elimination of property taxes for schools.

<u>William Jackowitz</u> Scranton resident spoke in favor of the uniform policy and also that he hopes the board has taken their time and makes the right decision when appointing an individual for the vacant school board seat.

Mr. Jackowitz also spoke of Pennsylvania school districts website and is disappointed that the Scranton School District ranked 419th out of 550 schools in the state.

<u>Sandra Brady</u>, Scranton High School PTSA President, spoke about the lack of school spirit at Scranton High School and how disheartening it is. Ms. Brady suggested an Athletic Pass that the students can buy to attend any athletic school function to help raise school spirit and also as a fund-raising tool.

Ms. Brady now informed the board that the students are no longer allowed to have pretzel sales at Scranton High School and that they were asked to leave the building. She was told directly that the school board voted against the pretzel and bake sales although she doesn't believe the school board would do that. Ms. Brady added that over \$2,000.00 was raised for a student within the Scranton School District who is very ill and the students were very proud they raised that money for this student.

President Lesh apologized to Ms. Brady and said that the board has had no involvement with stopping the fund raising sales and they will address the situation.

Director Sheridan also responded and said that he cannot recall a resolution that this board passed regarding the stoppage of any fund raising sales.

A brief discussion now took place between Ms. Brady, President Lesh, Mr. William King and Mr. Bill Gaynord about fund raising sales and the food services contract.

President Lesh felt that Aramark will be cooperative and come to an agreement regarding the pretzel and bake sales and asked that this be rectified as soon as possible.

<u>Gerard Hetman</u> of Lackawanna County Community Relations introduced himself and informed the board that he will be attending the monthly school board meetings to update the Scranton School District of Lackawanna County government and upcoming events in Lackawanna County.

<u>Rachel Mercuri</u> teacher at Scranton High School thanked Directors McGuigan and Ruane for their recent visit to Scranton High.

Ms. Mercuri also spoke on the following:

• Uniform Policy/Dress Code

Ms. Mercuri said that as teachers their biggest concern is that the uniform policy/dress code is the **least** of their concerns. Ms. Mercuri added that the teachers would rather have a student who is wearing a hoodie who listens and does their work rather than one who **IS** in dress code, who with every direction given is met with an argument or cursing. It is a daily reality that the teachers deal with.

- Frustrated with the incredible defiance that they are met with routinely being cursed at by students for simple requests such as remove their earphones or put away their hoodie.
- Ms. Mercuri has gone through all of her disciplines that she has had throughout the year and the number of dress code violations was about even with the disruptive and defiant actions.
- Asked the board to reinstitute In-House Suspension; Out of School Suspension is a reward for most of these students not a punishment.

President Lesh responded to Ms. Mercuri and said there have been quite a few discussions about discipline issues and said help is on the way, adding that a very informative Education Committee meeting was held recently and there is going to be a committee formed involving faculty and administrators to help rectify the problems in the classrooms.

Director Barrett also assured Ms. Mercuri that there is light at the end of the tunnel; a Discipline Committee is being created which includes the teachers union, administrators and board members.

Ms. Mercuri now asked the board to please reconsider when renewing the contract with Aramark. As far as she is concerned they are in breach of contract if they think they are serving healthy meals to our students.

<u>Rosemary Boland</u> SFT President, thanked Director Barrett and other members who attended last week's Education Committee meeting. Ms. Boland thinks it was very productive and appreciates that administrators were present.

Ms. Boland now invited the board members to attend a public rally on April 14, 2012 at the Lackawanna Courthouse to call attention to the harm that budget cuts are doing to our students. We must stand together and tell the governor that enough is enough.

At this time, President Lesh again waived the rules of the board and move out of order and asked for a motion to fill the vacant seat on the Scranton School Board.

Director O'Shea made a motion to nominate Mr. Armand Martinelli to fill the board vacancy. The motion was seconded by Director Shrive and passed with seven (7) affirmative and one (1) negative vote. Director McGuigan cast the negative vote.

Mr. Armand Martinelli was now sworn in as a Board Member of the Scranton School District by Solicitor John Minora.

President Lesh once again waived the rules of the board to have the following resolutions read.

NOW, THEREFORE, BE IT RESOLVED that the Scranton School Board officially agrees to adopt a high school uniform policy that will go into effect at the beginning of the 2012-2013 school year and will be developed by a committee of stakeholders and later approved by the full Board of Education.

ON THE QUESTION:

Director McGuigan indicated she would be voting against this resolution because without having a uniform policy developed it is senseless to pass a policy by just saying we're going to adopt a policy and hopes that the administration of our high schools don't think that a uniform policy is going to solve the problems. There is a problem with discipline and a problem of support of the teachers. The only kids that are going to follow the uniform policy are the ones that are currently following the dress code policy.

President Lesh also commented and said there has been a lot of debate over a uniform policy and it is something that needs to be put into effect by the next school year. Mr. Lesh added that the uniform policy is just the beginning and is part of the disciplinary issues that the committee will address.

Director Sheridan added that he agrees with both President Lesh and Director McGuigan regarding a uniform policy but it starts with the administrators at the schools and the students need to know that there are policies in place that need to be followed.

The resolution was seconded by Director Sheridan and passed with eight (8) affirmative and one (1) negative vote. Director McGuigan cast the negative vote.
