The School District hereby authorizes the issuance of if tax anticipation notes in an aggregate principal amount not to exceed $\$ 12,500,000$ (the "Notes") pursuant to the Local Government Unit Debt Act enacted July 12, 1972, as amended; the Notes shall be issued from time to time in such amounts as shall be determinedly the School District, provided that the amount of Notes to be issued shall be within the limitations set forth in the Local Government Unit Debt Act and shall not be greater that the estimated maximum cumulative cash flow deficit of the School District during the period in which the Notes will be outstanding, as determined under the Federal Income Tax Rules relating to arbitrage bonds.
2. The Notes shall be in substantially the following form, such insertions or variations are as appropriate.
